2. UNIONVILLE BOOSTERS CLUB PROVIDES NO INSURANCE. All insurance must be placed and/or paid by the exhibitor. We/I hereby relieve the Unionville Booster Club and all property owners of any responsibility in connection with the safe keeping of the exhibitor's property while said properties are on the specified ground are.
3. AREA MUST BE CLEANED BEFORE LEAVING. REFUSE MUST BE TAKEN WITH YOU. NO ALCOHOLIC BEVERAGES. IF THIS RULE IS ABUSED YOU WILL NOT RECEIVE ANOTHER CONTRACT.

6. ALL MOTOR HOMES AND CAMPERS MUST BE IN THE FIELD BY 7:00 AM. ALL VENDORS IN SPOTS IN THE FIELD BY 8:00 AM.
